

Welcome to the Publication Scheme for Cwm Taf Morgannwg Community Health Council

What a Publication Scheme is

Community Health Councils are independent bodies which are accountable to the National Assembly for Wales and the Minister for Health and Social Services for meeting their statutory representative and financial duties. The National Assembly for Wales together with NHS Trusts, Local Health Boards, Community Health Councils, General Practitioners, Dentists, Pharmacists and Opticians providing NHS services are individually required to provide a Publication Scheme under the Freedom of Information Act.

This Publication Scheme is a complete guide to the information routinely published by Cwm Taf Morgannwg Community Health Council. It shows how this information is published and whether any fee is payable. We will review the Publication Scheme at regular intervals and monitor how it is operating.

It is important to us that this Publication Scheme meets your needs and we have designed it to be a route map so that you can find information about Cwm Taf Morgannwg Community Health Council easily. Under Section 19 of the Freedom of Information Act 2000 (there is a link to the Act in Part Three below), Cwm Taf Morgannwg Community Health Council has a legal duty to adopt and maintain a Publication Scheme for the publication of Cwm Taf Morgannwg Community Health Council information. The purpose of the Act is to promote greater openness by public authorities (of which Cwm Taf Morgannwg Community Health Council is one).

PART ONE: INTRODUCTION

Community Health Councils (CHCs) were set up by Parliament in 1974 as independent bodies 'to represent the interests of the public in the health service in their district'.

Since 1 April 2015 when the Community Health Council Regulations 2015 (SI 2015 No 509) came into effect there have been seven Community Health Councils in Wales covering the same areas as those covered by the seven Local Health Boards. Each CHC is required to establish Local Committees, the boundaries of which correspond to the Local Authority areas in their region. Cwm Taf Morgannwg CHC currently has three virtual committees covering Bridgend, Merthyr and Rhondda Cynon Taf Local Authority areas.

CHCs act as watchdogs for the NHS in Wales. Their main roles are to:

- Monitor the effectiveness of NHS planning
- Evaluate the quality of services provided
- Ensure that the views of patients and members of the public are fairly represented in any important decision making process
- Assist and support patients and the public with any complaints against the National Health Service

There is also a Board of Community Health Councils in Wales. The main role of the Board is to regulate, monitor and ensure the quality of all work carried out by the CHCs around Wales. The Board also acts as the national voice for patients.

Cwm Taf Morgannwg CHC is an independent statutory organisation accountable to the Welsh Government and the Minister for Health and Social Services for meeting its statutory representative and financial duties.

Information Management

Information published through this publication scheme is held in line with the Information Management Policy for Record

Keeping and Disposal developed by the Board of Community Health Councils in Wales. Information required for the business purposes of the Community Health Council is stored at Cwm Taf Morgannwg CHC, Ground Floor, Ty Antur, Navigation Park, Abercynon, CF45 4SN.

In our Publication Scheme, you will find descriptions of the kind of information we intend to publish – the heading for these descriptions are called ‘Classes of Information’. Sometimes, we will not be able to publish all the information which is held by the Community Health Council. In these instances, we will tell you why. We will not be publishing personal or sensitive information and at all times we will have regard to the Data Protection Act and the Human Rights Act. We will also tell you, in each Class, what the limitation of time is on information we publish – if you want to see information in that Class which is older, please contact the person shown in the scheme.

In addition to the information we publish, the scheme contains information about other bodies e.g. the Board of Community Health Councils in Wales, which might also hold information relevant to the work of Community Health Councils.

We undertake to review this scheme at regular intervals with a view to extending the range of documents we routinely make available.

Your Rights of Access to Information

Freedom of Information Act

- The Freedom of Information Act recognises that everyone has the right to know how public services such as Community Health Councils are organised and run, how much they cost and how you can make complaints if you need to. You have the right to know which targets are being set, the standards of services that are expected and the results achieved.
- From 1 January 2005 every Community Health Council has to respond to requests about the information which it holds and a right of access to that information is created. The rights to request and access this information are subject to some exemptions, which the Community Health

Council has to take into consideration before deciding what information can be released.

Code of Practice on Openness

- At the present time, in addition to accessing the information identified in this Publication Scheme, you are entitled to request information about Cwm Taf Morgannwg Community Health Council under the Code of Practice on Openness in the NHS issued by the Welsh Office in 1995. Hard copies of this document are available free of charge from the NHS Wales Department of the Welsh Government. Sometimes, some or all of the information requested cannot be provided and we will explain the reasons why in our response should this happen.

Welsh Language Scheme

- Prior to 31st May 2019, the CHC had a Welsh Language Scheme approved by the Welsh Language Board. From 31st May 2019, the Welsh Language Commissioner has applied a number of standards to the CHC. Environmental Information Regulations

- The Environmental Information Regulations 2004 which came into force on 1 January 2005 set the standard for the release of information about the environment in which we live and work. Information relating to the Environment can be requested using these regulations and the Code of Practice on Openness in the NHS.

In adopting this Publication Scheme, we are committed to being as open as possible but there are instances where, for legitimate reasons, certain parts of the information will be withheld. The Freedom of Information Act 2000 permits the withholding of material which is covered by its exemptions. 1 NHS WALES AND HOW WE RELATE TO IT

Information about how Health Services are organised in Wales and our relationship to them. Information relating to the organisation of Community Health Councils in Wales and how Cwm Taf Morgannwg Community Health Council fits into this structure. Information about the relationship between Cwm Taf Morgannwg Community Health Council and Cwm Taf Morgannwg University Health Board and any other UK, National, Regional bodies with whom it is involved

Information about how Health Services are organised in Wales and our relationship to them

- **The NHS in Wales**

There are 7 Local Health Boards in Wales with specific geographic responsibility and also Health Trusts with specific specialist roles i.e. Welsh Ambulance Services NHS Trust and Velindre NHS Trust.

These Local Health Boards (LHBs) are responsible for planning the health services that local people need and want and for planning & paying hospital services family doctors, dentists and others to provide these services. Each LHB has a Board that makes decisions.

Community Health Councils are Associate Members of the LHB in their area, with the right to speak but not vote at Board meetings. Each Local Health Board (LHB) has a duty to consult the relevant Community Health Council(s) on proposals for any substantial developments of the health service in its district, and to provide them with information about the planning and operation of health services in its area.

- **Working Together to improve health in Wales**

Local Health Boards and local councils have a statutory duty to work together – in partnership with other local organisations – to produce strategies for improving health, social care and well being for the people living in their area.

The LHBs are also expected to work closely with their local population, consulting on significant changes and listening to local views.

- **Specialised Services**

Around three quarters of the budget for the NHS in Wales goes to Local Health Boards, but there are a few specialised services which are better planned across the whole of Wales. These include emergency ambulance services, cardiac surgery and some children's services.

The Welsh Health Specialised Services Committee (WHSSC) is responsible for Specialised and Tertiary services ("third level") on behalf of Health Boards in Wales. These services are not delivered at every hospital but at regional or national centres, the most specialist ones being provided at only one or two centres in the whole of the UK.

- **Public Health**

Each Local Health Board is responsible for delivering all health care services within its region. Public Health Wales provides each health board and its Director of Public Health with specialist public health support.

- **Ambulance Services**

Ambulance services across Wales are provided by the Welsh Ambulance Services NHS Trust. In order to monitor and influence the delivery of this service Community Health Councils are represented at the Trust Board meetings.

- **Links between LHBs and Community Health Councils**

The table below shows the links between Community Health Councils and the Local Health Boards.

Information relating to the organisation of Community Health Councils in Wales and how Cwm Taf Morgannwg Community Health Council fits into this structure

There are 7 Community Health Councils in Wales working conterminously with their equivalent Local Health Boards.

The size and structure of a Community Health Council (CHC) varies according to its geographical area, population size and patient flows.

All CHC Members are lay volunteers who receive nothing but their expenses. CHCs may from time to time also co-opt additional members as considered necessary to carry out the work of the Council. However, co-opted members may not vote at any meetings or proceedings of a Council or its committees. The work of each CHC is supported by a small number of paid staff.

The table below lists the Community Health Councils and demonstrates how they link to the Local Authorities in their area.

a) Statutory Framework

Community Health Councils (CHCs) were set up by Parliament in 1974 as independent bodies 'to represent the interests of the public in the health service in their district.'

In January 2001 the decision to retain CHCs in Wales was announced by the Welsh Assembly Government and reorganisation of 20 CHCs into nine federations was undertaken.

In January 2010 following a series of public consultations held during 2009 the Welsh Government decided on a further reorganisation. On 1 April 2010 seventeen CHCs were dissolved and 8 new CHCs coterminous with Local Health Boards created. Following the recommendations of the Longley Review and subsequent change in legislation on 1 April 2015 the two CHCs in Powys (Brecknock and Radnor CHC and Montgomeryshire CHC) amalgamated to form Powys CHC.

The membership, proceedings and performance of functions of Community Health Councils are laid down in Statutory Instruments. The brief description below is based on the Community Health Council Regulations 1996 and 2004 (SI 1996 No. 640 and SI 2004 N.905).

In 2003 a national Complaints Advocacy Service was introduced in Wales, managed by CHCs.

From April 2009 Local Health Boards and Health Authorities in Wales amalgamated and the role of the Local Health Boards expanded to include the work of the Health Trusts. In order that CHCs were able to accommodate the changes in 2010 the Welsh Government introduced the following Welsh Statutory Instruments: -

- 2010 No. (W) National Health Service, Wales, Community Health Councils (Establishment, Transfer of Functions and Abolition) (Wales) Order 2010, and
- 2010 No. (W) National Health Service, Wales, Community Health Councils (Constitution, Membership and Procedures) (Wales) Regulations 2010.

CHC Regulations 2015 (SI 2015 No 509) placed increased emphasis on the responsibility of the Board to advise CHCs with respect to the performance of their functions in particular, in relation to the provision of complaints advocacy services, the scrutiny of the operation of the health service, including the inspection of premises, engagement with the local population and content of reports to the Welsh Ministers that may be made under regulation 27(7) and (9).

The Board is also required to set standards in relation to the delivery of CHC functions and to monitor and manage the performance of Councils to ensure the consistent application of set standards.

STATUTORY POWERS AND FUNCTIONS OF COMMUNITY HEALTH COUNCILS

• **Membership of Councils**

Members are appointed by the relevant Local Authorities, by Voluntary Organisations and Welsh Government from applicants responding to public advertisements. The total number of members appointed to each Council by the appointing bodies is set out in the Welsh Statutory Instrument 2010 No. 288 (W.37), Schedule 1.

Members are subject to a term of office of between one and four years as specified by the appointing body on appointment.

A member may, on the expiration of the original term of office be eligible for re- appointment subject to a maximum term of eight years.

• **Proceedings of Councils**

From among their number Members elect a Chair and a Vice-Chair (or two Vice-Chairs), and they may appoint one or more Committees to exercise some of their functions.

In addition, members of local committees must also appoint a Chair and Vice Chair from among their number. The appointed officials will also form the Executive Committee of the Community Health Council.

It should, however, be noted, that: -

- Members appointed Chair or Vice Chair to the Community Health Council may not be appointed as chair or vice chair of a local committee.
- The Chair and Vice Chair of the Community Health Council will also be members of the Board of Community Health Councils in Wales.

The work of each Council is supported by a Chief Officer, and each Council is required to produce and disseminate a written Annual Report on the performance of its functions.

- **Performance of Functions**

- Each Council must appoint committees (known as local committees) for each of the relevant local authority area(s) within their district.
- Each Council has a duty to keep under review the operation of the Health Service in its district.
- The relevant Local Health Board (LHB) has a duty to consult the Council(s) on proposals for any substantial developments of the health service in its district.
- The relevant LHB has a duty to provide a Council with information about planning and operation of health services in its area.
- A Council may **enter any premises providing NHS care** for the purpose of monitoring or inspection.
- Each LHB has a duty to arrange at least one meeting a year between its members and CHC members.
- Each Council must, by 1 September of each year, make an Annual Report in writing to the Welsh Ministers regarding the performance of its functions during the period of twelve months ending on 31 March in that year.

- Cwm Taf Morgannwg Community Health Council covers a population of approximately 390k residents.
- We are represented on Cwm Taf Morgannwg University Health Board. Associate Member status gives us the right to speak but not to vote.
- We monitor the delivery of local health services by **Cwm Taf Morgannwg** University Health Board relating to primary, secondary, acute as well as community services and mental health services.
- We liaise regularly with other Local Health Boards and NHS Trusts which provide specialised services for **Cwm Taf Morgannwg** residents.
- We take part in the activities of the Board of Community Health Councils in Wales.

2 OUR STRUCTURE AND HOW WE CARRY OUT OUR STATUTORY DUTIES

Cwm Taf Morgannwg Community Health Council

- There are 36 Members, twelve members for each of the CHC local committees in Bridgend, Merthyr and Rhondda Cynon Taf.
- Each of the three local committees has three members appointed by their respective local authority, three by the Voluntary Sector and six by the National Assembly.
- We can also appoint Co-opted Members

- Meetings of the full Council are held six times per year, one of these being the Annual General Meeting in April, and are open to the public.
- Details of the forthcoming Council meetings are issued for display locally.

Committee Structure

The Council delegates some of its functions to Committees.

The Committees are listed below:

- Executive Committee held monthly open to the public
- Services Planning Committee bi-monthly open to the public
- Monitoring & Scrutiny Committee quarterly

How we function

- We exercise our statutory powers and duties to represent the public interest in the NHS and to hold NHS bodies to account
- Our monitoring of local health services includes
 - Carrying out a programme of monitoring visits to hospitals and other locations
 - Regularly attending Board level meetings of Cwm Taf Morgannwg UHB, Cwm Taf Morgannwg Health and Social Care Partnership Board
 - Taking part in informal liaison meetings with senior NHS managers
 - Being represented on a range of key committees covering aspects such as Quality and Safety and Patient and Public involvement
 - Having representatives of local NHS bodies attend CHC meetings in public
 - Organising public meetings or other forms of consultation to find out views of patients and public
- We bring the special needs and concerns of our residents to the attention of the National Assembly and other bodies
- We seek to raise public awareness of NHS issues
- We provide information and non medical advice to the public
- We offer free independent advice and support to patients raising concerns about the health service
- At the national and regional level, we contribute to the work of a number of NHS Committees and Clinical Networks

Reviews

It is the role of the Board of CHCs in Wales standards & performance committee (S&PC) to provide assurance to the board that CHCs are working in accordance with (or demonstrating they are working towards) the national standards for CHCs in Wales.

In order to discharge this function each year S&PC seek assurance that CHCs are regularly and robustly self-assessing their performance against the standards, and using this self-assessment to develop its ways of working.

Advice and Advocacy

We provide free and independent advice, assistance and support on many different aspects of health care and act as a patient's friend or advocate in relation to complaints about NHS services.

3 HUMAN RESOURCES

Our staff and matters relating to their recruitment, employment, development and training

CHC Office

The work of each Community Health Council is supported by a small team of paid staff. The staffing structure for Cwm Taf Morgannwg Community Health Council is:

- Chief Officer
- Deputy Chief Officer
- Business Manager (0.7 whole time equivalent)
- Patient & Public Engagement Officer (0.7 whole time equivalent)
- Three Complaints Advocates (2.25 whole time equivalent)
- One Advocacy Support Officer
- Two Admin Assistants

Core Services

Each Community Health Council receives advice and support on personnel and finance matters from the Business Services Centre, part of Powys Local Health Board. Under an agreement between the LHB and the Welsh Assembly, these essential support services are provided on an agency basis. The agreement incorporates a 'firewall' to ensure that the independence of Community Health Councils and Powys Local Health Board is not compromised. The services are provided by Powys LHB staff located in the North Wales Business Services Centre.

As the legal employer of CHC staff, the LHB provides employer functions in respect of contracts, payroll, health and safety policies etc. However, decisions relating to the recruitment and appointment of staff can only be made with the prior agreement of the Authorised Officer designated by the Board of Community Health Councils.

In this way Community Health Councils are provided with the support services they need, but the strategic direction and activities of each Council are decided by the individual Council within the recognised core functions of Community Health Councils.
